ACADEMIC AND HIGHER EDUCATIONAL COLLABORATION

Raden Intan State Islamic University of Lampung, Indonesia, and University of Halabja, Kurdistan Region, Iraq wishing to enhance relations between the two universities and to develop academic and cultural interchange in the areas of education, research, and other activities. The areas of cooperation will include any program offered at either institution which is felt to be desirable and feasible for the development and strengthening of cooperative relationships between the two institutions. However, any specific program shall be subject to mutual consent, availability of funds, and approval of each institution.




**HAVE AGREED AS FOLLOWS**

**Article 1  
OBJECTIVE**

The objective of this Memorandum of Understanding in Furtherance of the common interest of the signatory institution is to further develop and carry out collaboration along the lines set in article 2.

**Article 2  
SCOPE of ACTIVITIES**

The scope of collaboration on academic and education shall include but not limited the following categories:

1. Exchange of scholars in the course of academic development to address issue of scientific progress
  2. Exchange of scientific materials that is available by both parties.
  3. Research of interest to both parties
  4. Book writing, seminar, workshop, and other scientific meeting on matter of mutual interest
  5. Exchange of students in various us activities
  6. Any other cooperation has mutually agreed upon by the parties.

### **Article 3**

#### **PLAN OF OPERATION**

A detailed description of the scope of activities shall be defined in a plan of operation which shall be formulated following discussion and consultation among relevant staffs in Raden Intan State Islamic University of Lampung, Indonesia and University of Halabja, Kurdistan Region, Iraq.

### **Article 4**

#### **CONTRIBUTION BY BOTH PARTIES**

In accordance with the prevailing laws and regulation in Indonesia and Iraq and subject to personnel and budget limitations, Raden Intan State Islamic University of Lampung, Indonesia and University of Halabja, Kurdistan Region, Iraq:

Assign qualified expert, lecturers, and research supervisory staffs to assist in implementation of activities under this Memorandum of Understanding

1. Assist where possible in arranging for necessary permit for approved expatriate staffs and experts, which are needed to enter and leave the country wherever necessary including their work and stay permits.
2. Assist where possible in arranging such exemption from taxes and duties available in each country



## **Article 5 FUNDING**



The realization of activities related to the Memorandum of Understanding depends on the availability of funds, which should be sought established sources provided for such activities by each university.

## **Article 6 INTELLECTUAL PROPERTY RIGHTS AND PUBLICATION**

Each party shall continue to remain the sole owner of material it contributes to any joint project. The parties will work together to negotiate any appropriate licensing terms. The parties will seek opportunities for the co-publications will mention this cooperation between the parties.

## **Article 7 SETTLEMENT OF DIFFERENCES**

Any differing viewpoints and the interpretation of this Memorandum of Understanding shall be settled amicably upon mutual consultation and negotiation.





## Article 8 AMANDEMENT, DURATION, AND TERMINATION

1. Amendment to this Memorandum of Understanding can only be made after consultation and in writing by mutual consent between two parties.
2. This memorandum of Understanding shall be affected from the date of signing and be valid for the duration of three years from that date and will be automatically renewed on an annual basis thereafter unless terminated or replaced with Memorandum of Understanding.
3. Either party may terminate this Memorandum of Understanding by Written notice at least six months in advance. In case the Memorandum of Understanding ceases to be in effect on account of termination, the provision of the plan(s) of operation shall continue to apply to the extent necessary to secure the implementation of existing activities as agreed upon in the plan(s) of operation.
